#### UNIVERSITY OF MIAMI PRE-COLLEGE Student Responsibilities, Rules, and Policies

As a participant in the University of Miami Pre-College Program (Summer Scholars Program (SSP) or UM Academies Program), students also become a member of the University of Miami community. By becoming a member of the University of Miami community a student acquires rights in, as well as responsibilities to, the whole University community.

These rights and responsibilities are defined within this document in combination with the University of Miami Student's Rights and Responsibilities Policies found <u>here</u>.

Students are responsible for knowing and adhering to University of Miami Pre-College Student's Rights and Responsibilities Policies. The below policies will be reviewed in detail at the mandatory Pre-College Student Orientation.

If there are conduct/behavioral issues, the parents will be contacted. The students involved in a policy of Honor Code violation will face disciplinary action and the sanctions could be dismissal and removal from the Program. Fees will not be refunded and credit will not be awarded. Departure arrangements must be made by, and at the expense of the parent/guardian within 24 hours of notice.

#### HONOR CODE

Pre-College students are expected to abide by the University of Miami Undergraduate Honor Code, which provides the standards for ethical academic behavior and imposes penalties for violations of such standards.

Academic honesty is required of all students. Upon submitting academic work in writing, online, or in person, a student is declaring that work to be a product of their own thoughts and study, stated in their own words, and produced without assistance with the exception of proper citation of and reference to academic sources or other appropriate sources. Engaging in academic misconduct may result in failing an assignment, failing a course or program, and/or possible dismissal from the program without refund.

Students are expected to read and abide by the Honor Code found here (Zero Tolerance Policy).

#### ALCOHOL & DRUGS

The University has established policies and regulations which adhere to applicable federal laws and Florida statutes. The University is 100% smoke and tobacco free. Regardless of a student's age or the location of the Program (e.g. on campus, in residential halls, on field trips, etc.), Pre-College students may not possess or consume any alcohol, tobacco, e-cigarettes, personal vaporizer/vapor cigarettes, medications not prescribed to the student by a licensed medical professional, or illegal substances or paraphernalia while participating in the Program. The possession (including the presence of a substance), manufacture, distribution, use, sale, or abuse of illegal drugs on any portion of the University's premises is strictly prohibited. Students are subject to disciplinary action if found in violation. Parents/guardians will be notified and students will be immediately removed from the Program (Zero Tolerance Policy).

Students are permitted to have medication prescribed by their own physician and should inform the Pre-College Program Office if they need any clarification on the policy.

#### HEALTH INSURANCE

All students, including international, **<u>must</u>** have active health insurance to attend the program. Students will be required to submit proof of insurance before arriving on campus. Each student must bring a copy of their insurance information as they will be responsible for providing their insurance and billing information at patient intake, and responsible for subsequent medical bills.

#### NOISE & NUISANCE

Students and their guests are prohibited from activity creating any form of disturbance that is believed to be in violation of the ordinances in the City of Coral Gables, South Miami, or other municipality of record. Reasonable quiet hours are expected at all times in all areas of campus. Quiet hours begin at 10 PM each night. Noise should be kept to a minimum level 24 hours a day and should cease after 10 PM.

#### **CURFEW & VISITORS**

- 1. Commuter students and guests must depart campus by 10 PM.
- 2. Residential students must be in the residence hall and in their own rooms by 10 PM. **No exceptions**. Residential room checks will be conducted at 10 PM.
- 3. Commuter students and guests are not permitted beyond the lobby. Absolutely NO overnight guests are permitted.
- 4. Families are permitted to visit their students on campus (consider eating at a campus restaurant or bring dinner from a favorite restaurant). Students must accompany guests while on campus.
- 5. Students are not permitted to leave campus with <u>anyone</u> during the program, including a parent/guardian, unless there is an extreme circumstance or special need (i.e. medical appointments, family emergency, observing religious holy days). See Sign Out Requests Policy (page 5) for more details.
- 6. Students are required to sleep in their assigned room.
- 7. Between the hours of 7 PM and 9:30 PM, students who wish to leave the residential hall must:
  - a. Sign out and sign back in by 9:30 PM;
  - b. Have 1 or more individuals (student or PCL) with them; the buddy system is a requirement for the 7-9:30 PM time frame.
- 8. Students should not start laundry after 7:30 PM.
- 9. If ordering food for delivery, students are financially responsible for their food delivery order. Food must be scheduled to arrive <u>before</u> 9:30 PM at the residence hall and students must retrieve their own food order. Staff members will not be permitted to collect or deliver students' food orders. Food delivered after 9:45 PM will be forfeited and students will not be reimbursed for any food that has been forfeited due to late arrival.

#### COMMUTER STUDENTS

When classes are not in session, parents/guardians are responsible for their commuter students if they are not using a campus facility, are not at a Pre-College event or program on campus, or on a Pre-College program field trip.

#### LAKE OSCEOLA OR CAMPUS WATERWAYS.

No water activities, including, but not limited to, swimming, fishing, etc in Lake Osceola or the adjacent waterways is strictly prohibited.

#### SIGN-OUT REQUESTS

Students are <u>not</u> permitted to leave campus. This includes, but is not limited to, leaving campus with parents/guardians, family members, friends, other students, and ride-shares (Zero Tolerance Policy). There will be opportunities to travel off campus as part of the Pre-College planned activities.

Attendance is part of the student's grade. To ensure academic success and community building, which is achieved through time spent on campus, evening and weekend sign-out requests will <u>not</u> be approved unless there is an extreme circumstance or special need (i.e. family emergency, observing religious holy days). Requests should be sent via email to <u>precollege@miami.edu</u> and must be received by **Friday**, **June 21**. Requests after this date will not be considered.

Sign-out requests for ACT/SAT testing will <u>not</u> be approved. Medical appointments should not be scheduled during the duration of the Program. **Class attendance is mandatory and part of the student's grades.** 

Requests that are extreme circumstances or special needs require advance written notice to the Pre-College Program staff. Requests should be sent via email to <a href="mailto:precollege@miami.edu">precollege@miami.edu</a>

Parents/guardians are not permitted to sign out a student that is not their dependent. A student is only authorized to leave once the Pre-College Office sends the student's parent/guardian a confirmation via email. Please note that students must return to campus by 9 PM the same day.

By accepting admission into this Program, the student is agreeing to solely commit for the duration of the Program and forego any other outside commitments. Residential students are not permitted to be signed out for the following: academic testing, sports practices, work, internship, clubs, competitions, outside academics, etc.

#### **PARKING & TRANSPORTATION**

Commuter students are responsible for transportation to/from campus. Commuter students are permitted to have their cars, bicycles, or scooters on campus and must follow <u>University Parking Policies & Procedures</u>.

Residential students are not permitted to have their cars on campus and are not permitted to travel in commuter students' vehicles (Zero Tolerance Policy).

All bicycles and scooters are required to be registered with the University of Miami Police Department (UMPD) as part of the Bicycle Safety Program. Bicycles and scooters stored illegally may be confiscated by authorized University personnel, and disciplinary action taken. Bicycles and scooters may not be ridden inside University buildings.

#### **RESIDENCE HALLS AND UNIVERSITY PROPERTY**

University property may not be removed from the living units or from the public areas. All rooms are equipped with standard furniture and damage charges will be assessed against the individual(s) responsible. If individual(s) responsible for damages, over and above normal wear and tear, cannot be determined, the students assigned to the damaged room will be assessed equally. Students are not permitted to repair damaged University property. All damaged University property must be reported to Pre-College staff and Conference Housing immediately. Arrangements for necessary repairs and assessed charges, when appropriate, will be made by Conference Housing and subsequently charged to the individual(s) account(s). Any damage to property belonging to the University, assigned residence hall, or another person is prohibited and will require restitution.

#### **RESIDENTIAL HOUSEKEEPING & MAINTENANCE**

Residential students must clean their own rooms and bathrooms. Students are responsible for disposing or recycling their trash in designated receptacles on their floor. Leaving trash outside of a residential space, door, or in the hallways is not permitted at any time. Failure to comply will result in disciplinary action.

#### **ELECTRICAL APPLIANCES**

Students are allowed to use microwaves, popcorn poppers, coffeepots, and hot pots, provided all have encased heating units. All other heating devices are a fire hazard and may not be used in the residence hall. Any unauthorized heating devices will be confiscated from the student's room.

#### FIRE HAZARDS

- A. **Candles and Incense** Candles and incense are prohibited in housing. Violations may be subject to disciplinary action.
- B. **Cooking** Cooking is not permitted in rooms except for the use of items which have encased heating elements, (e.g., popcorn poppers, microwaves, coffee makers, etc.).
- C. **Fire Escapes** Propping open the fire escape doors is prohibited. Loitering and/or smoking on the fire escapes is also prohibited.

- D. **Fireworks** Fireworks are not permitted in housing for any reason. Any person found in possession of fireworks will be subject to immediate disciplinary action and/or expulsion from housing.
- E. Smoking Smoking is prohibited on the University of Miami Coral Gables campus.

#### **EMERGENCY MANAGEMENT**

If the University anticipates impacts from a Category 1 or greater storm, program participants will need to make their own arrangements to evacuate the campus and return home. In the event of Category 1 or greater storm, parents/guardians for all participants will be notified that an evacuation is being ordered and are expected to arrange transportation for their student.

Program communications will be sent to the parent/guardian's email provided in the student's application. Parents and guardians are encouraged to opt-in to receive University of Miami Emergency Notification Network (ENN messages) here.

The University will make reasonable efforts to complete the program remotely depending on the extent of impacts from the storm.

#### **CELL PHONES AND CAMERAS**

Students are not permitted to photograph or record in bathrooms or changing areas. Additionally, students should not record other students, staff, or faculty without their consent. <u>Florida Statute 934.03 regulates the recording of conversations in Florida</u>

#### SKATEBOARDING, ROLLER SKATING, ROLLERBLADING, AND USE OF SCOOTERS

Skateboarding, roller skating, rollerblading, hoverboards, and the use of scooters is prohibited inside University housing buildings, hallways, common spaces or apartments.

#### HALL SPORTS/ACTIVITIES

Students may not engage in any sport or sport related activities within University housing rooms/apartments, lounges, hallways, stairwells, or other public areas. Sports or sports related activities include, but are not limited to: Frisbee, floor hockey, golf, bowling, football, soccer, baseball, rollerblading/skating, scooters and basketball. Students may not engage in chaotic collective behavior. Students may not use food as projectiles. Students may not use water pistols, super soakers, or any other mechanism that projects water in the above-mentioned areas. Also, students may not use foam or projectile style toy guns or any other device that resembles a weapon.

#### WINDOWS AND EXTERIORS OF RESIDENTIAL BUILDINGS

Objects shall not be thrown from any window, doorway, landing, or stairwell. No object or material may be placed in, on, or hung from, in front of, or behind windows which block transparency or alters the appearance of the windows or the exterior of the building. Also, no object (e.g., signs, banners, aluminum foil, towels, sheets, ropes, wires, etc.) may be placed on the exterior of the building. Students shall not utilize windows as a form of communication with students/staff in other rooms or programs.

#### **ROOM ACCESS/ADDITIONAL HOUSING CHARGES**

Residential students will access their room using their Cane Card (student ID). If students lose their Cane Card, they should immediately alert the front desk and request a new Cane Card from the Cane Central building (open during business hours) for a fee of \$25. If the student's Cane Card is lost after business hours, the student can receive a temporary room access card from the front desk. Upon receiving a new Cane Card, students need to have their access reinstated at the front desk and <u>must</u> return their temporary room access room card.

- Lost/Unreturned Room Access Card Fee: \$75\*
- Students who are locked out of their room will incur a charge of \$25 for each lockout.\*
- Students are responsible for reporting any damages or situations where deep cleaning is necessary. A Cleaning Charge \$200.00\* max per room, assessed after use if necessary. If individual responsibility for damages, over and above normal wear and tear, cannot be determined, the guests assigned to the damaged room will be assessed equally.
- Missing Linens: If linens are missing at the conclusion of the Program, students will be charged a per item fee. Fees will be split equally between roommates.

#### \*Fees are determined by the Housing Department and are subject to change.

Any additional fees incurred during the Pre-College Program will be charged to the student's account and visible on CaneLink. The balance must be paid-in full before grade reports/transcripts are released. Unpaid fees will follow UM's collection policy and procedure. Please be aware that due to the nature of the reconciliation process, housing fees may not appear on your student account until September after the program has concluded.

#### 'CANE CARD (Student ID)

The University of Miami provides each student with one identification card. The 'Cane Card gives students access to buildings such as the residential hall (residential students), classrooms, Otto G. Richter library, computer laboratories, and the Wellness Center (gym). The Cane Card is required to be carried at all times and students must be prepared to show it if asked by a University official. Refusal to show proper ID when requested violates University policy.

Lost or stolen cards should be reported immediately to be deactivated to prevent them from being used by unauthorized persons. A \$25 replacement fee will be charged to the student's CaneLink account for replacement of a lost ID card. Financial holds are placed on accounts with an unpaid balance and can prevent the release of transcripts.

ID cards can be kept at the end of the Program. Should the Pre-College student become an undergraduate at UM, the student will not receive a new 'Cane ID but will continue to use the ID from the Pre-College Program.

Students will receive instructions to their Program application email address and University of Miami email address on how to upload a picture for their 'Cane Card. Photos should be submitted not later than **May 31, 2025**. Please follow the instructions carefully to ensure your 'Cane Card will be printed and available at student check-in.

#### CLASSROOM PRINCIPLES AND EXPECTATIONS

- A. The classroom, whether physical or virtual, is intended to be a safe and secure environment for learning;
- B. Trust and collaboration are keys to integrity;
- C. Pay careful attention to your instructors' rules and guidance regarding the sharing of class learning materials, permitted forms of collaboration, and other behaviors related to learning and teaching;
- D. Students are responsible for maintaining the shared privacy of their class for the benefit of their peers and instructors as well as themselves;
- E. The deliberate sharing of private images, communications, learning materials or other depictions of other students or your instructors for the purpose of inviting external commentary, ridicule, or embarrassment, is prohibited; and
- F. Ultimately, our classrooms are communities built on trust and our learning and teaching relies upon a shared sense of respect, integrity, and common purpose.

#### CLASSROOM DECORUM

Behavior in the classroom that impedes teaching and learning and creates obstacles to this goal is considered disruptive and therefore subject to discipline. Students have the responsibility of complying with behavioral standards. Examples of improper behavior in the classroom (including the virtual classroom of email, chat rooms, telephony, and web activities associated with courses) may include, but are not limited to, the following: arriving after a class has begun, distractive talking, including cell phone usage; audio or video recording of classroom activities or the use of electronic devices without the permission of the instructor, refusal to comply with reasonable instructor directions, employing insulting language or gestures, or verbal, psychological, or physical threats, harassment, and physical violence.

#### VIRTUAL CLASSROOM DECORUM

- A. Find a quiet space to attend your virtual class
- B. Mic on (mute when not talking to avoid feedback)
- C. Camera on (use a virtual background if available)
- D. Be fully and appropriately dressed and in a quiet space in your home (laying on your bed or couch is not acceptable during live instruction)
- E. Be prepared to engage in the lesson. Do not log on and off.
- F. Pay attention to class and not to be involved in non-school related activity or conversation.
- G. When the camera is on avoid distracting movements or actions in the camera (Avoid bringing your pet or other objects into the camera view)
- H. Check that that you have adequate lighting and that you are visible on the camera
- I. Consider putting a live sign on your door so that others know that you are actively engaged in a class

#### DISORDERLY CONDUCT/HARASSMENT OR HARM TO OTHERS

Failure to comply with the policies noted below is prohibited.

- A. Loud, threatening or aggressive behavior or any other behavior which disturbs the peace and/or impedes the rights of other person(s); and/or disrupts the orderly functioning of the University;
- B. Lewd, indecent or obscene conduct or expression made by any means;
- C. Disruptive behavior which substantially interferes with, obstructs, or in any way negatively impacts the safety, viewing, or enjoyment of other attendees in the context of a University of Miami event, or when traveling to or from an event.
- D. Unwelcomed and/or discriminatory words or acts, whether intentional or a product of the disregard for the safety, rights, or welfare of others, which intimidate, degrade, demean, threaten, bully, haze or otherwise interfere with another person's daily activity.
- E. Words or acts that have the effect of excluding or are intended to exclude another student from participation under any program or activity of the university in violation of the University's Equal Opportunity / Non-Discrimination policy (contained in the Administrative Policies and Guidelines section of this Handbook)
- F. Words or acts considered as a bias incident. A bias incident is defined as an action, behavior, or expression against an individual's or group's actual or perceived identity.

#### ONLINE/INTERNET SOCIAL NETWORKING USAGE

All students are responsible for their postings on the Internet and/or social networking sites. Prohibited usage of Internet/social networking sites may include:

- A. Stalking, harassing, or threatening another person or group;
- B. Creating language or images on a social network that are hateful, threatening, offensive, vulgar, or derogatory;
- C. Displaying or being displayed in an activity that violates federal, state, or local law and/or any regulation outlined in the University of Miami Student Rights and Responsibilities.

#### ACADEMICS/GRADES

Students in the Summer Scholars Three-Week Credit Program are enrolled in credit courses. Students earn college credit upon successful completion of the course. Their official academic record at the University of Miami will include classes taken, grades earned, and grade point average (semester average and cumulative average). Grades earned during the program will be included in the calculation of the student's overall academic record should they gain entrance to the University as an undergraduate student.

Students enrolled in the UM Academies Two-Week Non-Credit Program will earn a mark of "Satisfactory" or "Unsatisfactory" which will be part of their academic record.

#### HOLDS/STUDENT RECORDS

The Pre-College department and the Summer Scholars Program have the ability to put holds on student records. These holds can be financial, academic or disciplinary in nature and may delay a student's ability to register and/or to receive an official transcript. Holds on a student's record normally require action on the part of the student, i.e., a payment, completion of paperwork and/or disciplinary sanctions, etc. Specific information on a hold and what is required to remove it can be obtained from the Pre-College department.

#### ATTENDANCE

Pre-College students should be focused and prepared to apply themselves academically. Class attendance is mandatory and part of the student's grades. Coverage of class material will be intense and absence would cause a student to fall behind in a course or program.

Students must attend and report on time to all of their classes and curricular events and activities as stipulated in their program or course syllabus. This applies not only to class time but to group projects, discussion sections, guest speakers, information sessions/activities, projects, homework, study sessions, office hours, and mentor meetings. Students will also be expected to actively participate in academic discussions and activities and visit professors during office hours when needed. Students should plan for coursework in the evenings after class and on weekends.

#### INCLUSION

The University of Miami embraces diversity and situates our students within a unique academic and social environment. University of Miami students enjoy the right to learn, both within and outside of the classroom. The University of Miami does not discriminate on the basis of race, color, religion, sex (including pregnancy), sexual orientation, gender identity or expression, genetic information, national origin, age, disability, marital status, familial status, or other prohibited classification, in its programs and activities, regardless of whether such program or activity occurs on or off-campus.

#### STUDENT ENRICHMENT

Evening and weekend activities have been planned to enhance the students' overall experience. To promote community building, students are strongly encouraged to be present and actively engage in evening enrichment activities. Activities are designed for students to interact with and become acquainted with the diverse Pre-College and University of Miami communities.

The individual student experience will be shaped by activity choices and level of involvement. Parents/guardians of commuters are encouraged to be flexible and accommodate class study groups and social activities. Students and parents/guardians will be presented with a calendar of activities prior to the start of the Program.


#### Can parents register to receive ENN messages?

#### Miami Roller Rink - Skating Liability Release & Waiver (as of 2/15/2024)

This document is a legal agreement between Miami Roller Rink & Events (hereinafter "the Company") and the participant (or participant's parent/guardian if under the age of majority).

- 1. General Facility Risks and Waiver Requirement: Risk exists by merely being present in the facility, regardless of activity participation. All individuals entering must have a signed waiver on file. This agreement applies to all activities within the facility, including roller skating, arcade games, and any other amenities on the premises.
- 2. Acknowledgment of Physical Fitness: I affirm that I am in good physical condition and have no illness, injury, or medical conditions that could be exacerbated by participation in the activities at the Company's premises.

#### ROLLER SKATING RINK SAFETY ACT FLORIDA LAW STATUTES SEC. 768.395

Florida Law (statutes sec. 768.395) provides that roller skaters and spectators assume the inherent risks in the activity of roller skating and that roller skating rink operators are not liable to roller skaters or spectators o for any damages or personal injury resulting from the inherent risks of roller skating.

While engaged in roller skating activity, roller skaters must:

- 1. Maintain reasonable control over his or her speed and direction of travel at all times.
- 2. Heed all posted signs and warnings.
- 3. Maintain a proper awareness to avoid other roller skaters and objects.
- 4. Accept the responsibility for knowing the range of his or her own ability to negotiate the intended direction of travel while roller skating and to skate within the limits of that ability.
- 5. Refrain from acting in a manner that may cause or contribute to his or her own personal injury or the personal injury of another

person Operators must:

- 1. Conspicuously post in at least three areas on the premises the responsibilities of roller skaters, spectators and the duties of operators.
- 2. Maintain the stability and legibility of all signs, symbols and posted notices required by law.
- 3. Have at least one roller skating rink supervisor or manager on duty for every 200 skaters when the roller skating rink is open for business.
- 4. Maintain the skating surface in a reasonably safe condition and clean and inspect the skating surface before each skating session.
- 5. Maintain in good condition the railings, kick-boards and walls surrounding the skating surface.
- 6. Ensure that all coverings on risers are securely fastened in roller skating rinks with step- up or step-down skating surfaces.
- 7. Install and regularly inspect fire extinguishers.
- 8. Inspect emergency lights at least quarterly to ensure the lights are in proper working order.
- 9. Keep exit lights and service area lights on when skating surface lights are turned off during a skating session.
- 10. Inspect and maintain in good mechanical condition roller skating equipment that the operator leases or rents to roller skaters
- 11. Comply with all applicable state and local safety codes.
- 12. Take reasonable action to correct a dangerous condition that is known or reasonably should have been known.

I hereby agree to release, waive, indemnify and hold harmless the University of Miami, its officers, directors, trustees, employees, faculty, students, volunteers, agents and representatives (collectively, referred to as the "<u>University</u>") from any and all claims, demands, damages, causes of action, suits, whether in law or in equity or however caused, against, including without limitation, any damage to or loss of personal property, any personal injury and/or death, which my child or I may have or may acquire as a result of his/her presence and participation in the programs, services, and facilities offered by the DWR, including, without limitation, damage, loss, injury and/or death caused by the negligence, in whole or in part, of me, my child, the University or any third party.
- 5. I understand and agree that this Consent, Waiver and Release Agreement applies whether the University of Miami is at fault or not.

- 6. I understand and agree that the University of Miami may not have medical personnel available at the DWR. I hereby grant permission to the University of Miami to authorize emergency medical treatment, if necessary, and agree that such action by the University of Miami shall be subject to the terms of this Consent, Waiver and Release Agreement. I understand and agree that the University of Miami assumes no responsibility for any injury or damage which might arise out of connection with such authorized emergency medical treatment.
- 7. I understand that in securing the execution of this Consent, Waiver and Release Agreement, the University of Miami is acting as agent or trustee on behalf of or for the benefit of its respective employees, agents, officials, faculty, students, servants and representatives, whether paid or unpaid, who shall to this extent be, or be deemed to be, parties to this Agreement.
- 8. This Consent, Waiver and Release Agreement shall serve to benefit and bind the University of Miami and myself and our respective heirs, executors, administrators, successors and assigns.
- 9. This Consent, Waiver and Release Agreement shall be governed and construed in accordance with the laws of the State of Florida, and any dispute arising from or relating to this Agreement shall be brought exclusively in a court of competent jurisdiction located in Miami-Dade County.
- 10. I certify that I have read the terms of this Consent, Waiver and Release Agreement and understand its contents, and that I wish to be bound by its terms.

I UNDERSTAND THAT THERE ARE RISKS OF INJURY INVOLVED IN MY CHILD'S PARTICIPATION IN THE PROGRAMS, SERVICES AND FACILITIES OFFERED BY THE DWR AND MY CHILD AND I VOLUNTARILY ASSUME SUCH RISK. IT IS MY INTENTION BY SIGNING THIS CONSENT, WAIVER AND RELEASE AGREEMENT TO EXEMPT AND RELIEVE THE UNIVERSITY OF MIAMI FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH CAUSED BY MY NEGLIGENCE, MY CHILD'S NEGLIGENCE, OR THE NEGLIGENCE OF ANY OTHER PERSON(S) PARTICIPATING IN, OR AFFILIATED WITH, THE PROGRAMS, SERVICES AND FACILITIES OFFERED BY THE DWR.
